Outstanding Individual who has achieved outstanding international performances.

**4) COMPASS Lifetime Achievement Award**

Nationally renowned individuals who are outstanding musicians themselves and at the same time has made continuous contribution to the development and nurturing of the local music talents in his or her entire life.

To make your nomination, please send a one-page summarized biography using the prescribed form. The information you give is the sole basis for choosing the recipient, so please complete your nomination as fully and carefully as possible. Additional information in support of this nomination may be appended.
